

Jackson Water Precinct
2015 Budget Hearing

The hearing was called to order at 6:00 p.m. by Moderator Matesky. Moderator Matesky announced he would read the budget line by line. Since no citizens of the Jackson Water Precinct were in attendance and there were no visitors in the audience, and since the commissioners are already familiar with the budget, Commissioner Meyers made a motion to not read the budget line by line as that would take a long time but rather by article.

This motion was second by Commission Pratt. All three Commissioner voted in favor of not reading line by line but categories.

Moderator Matesky read the following:

Article #1 To choose all necessary precinct officers. This will be voted on at the Annual Meeting on 04/01/15. Water Commissioner Patricia Donnelly's seat is up this year. Donnelly will run again.

Article #2 To raise and appropriate the sum of \$201,351.00 as necessary to defray Precinct cost for the ensuing year and to make appropriations for the same. The Commissioners favor.

Article #3 To see if the Precinct will vote to raise the appropriate sum of \$60,949.00 to pay the annual principal and interest on the Rural Development loans. The Commissioners favor.

Article #4 To see if the Precinct will vote to raise and appropriate \$32,907.00 to pay the annual principal and interest on the New Hampshire State Revolving loan payment. The Commissioners favor.

Article #5 To see if the Precinct will vote to raise and appropriate the sum of \$10,000.00 to be placed into the "Water Precinct Improvements" Expendable Trust Fund, the commissioners to be agents to expend from this fund. The sum will be taken from the Jackson Water Precinct's general fund surplus. The Commissioners favor.

Article #6 To act upon any other business which may legally come before this meeting.

Moderator Matesky then read a budget summary:
